

INSTRUCTIONS FOR FILLING ONLINE ANTI-RAGGING UNDERTAKINGS BY STUDENTS AND PARENTS

After commencement of classes each year, all students and their parents/guardians are required to fill online the anti-ragging undertaking in accordance with the guidelines of the Hon'ble Supreme Court of India and AICTE, New Delhi.

Step-1: Fill the online anti-ragging undertaking

Visit the anti-ragging official website <http://www.antiragging.in/> and click on the 'Fill Undertaking' option.

While filling the undertaking, select/enter following institute details:

Step-2: Download the Undertaking

After submission of undertakings, 'Anti-Ragging Undertaking Reference Number' will be sent to the registered email ID. The undertaking can also be downloaded from anti ragging web portal https://www.antiragging.in/undertaking_request.php

Step-3: Submit the Undertaking through Institute ERP

Students must log in to their ERP Account at <https://erp.skit.ac.in/> and go to submit 'Submit Anti-Ragging Undertaking Reference Number' option available in the left side navigation menu.

Upload the **ORIGINAL PDF** file of the undertaking and enter the anti-ragging undertaking reference number in the prescribed fields.
